DECISION OF THE BOARD

The Labour Relations Board, (the "Board") is concerned in this proceeding with a directive by the Minister of Labour, pursuant to Section 72 of the *Labour Relations Code* (the "Code"), to designate essential services.

The following designations are made pursuant to the Parties' agreement and are without prejudice or precedent to any future disputes involving any of the Parties:

- 1. The Board hereby designates the following facilities, productions and services as necessary or essential to prevent immediate and serious danger to the health, safety or welfare of the residents of British Columbia:
 - a. the continued safe supply of natural gas to the residents of British Columbia serviced or supplied by the Employer as provided under Schedule A and B, and including:
 - i. Emergency Response

To make safe any failures or damage to the natural gas system components to protect the public, emergency personnel, employees and the environment.

- 1. Emergent calls are for:
 - a. gas leaks,
 - b. fire, explosion and asphyxiation reports,
 - c. restoration of service where loss of gas could be a hazard to health, safety, welfare or property of the occupant(s),
 - d. damage to, or malfunctions of, any equipment which may pose a potential threat to the health, safety or welfare of the public, and
 - e. any use of LNG equipment which may be required in the interests of the health, safety or welfare of the public and in accordance with the foregoing conditions.
- ii. The maintenance or restoration of all facilities, productions, services and auxiliary departments for the continued operation of the natural gas system necessary to prevent immediate and serious danger to the health, safety or welfare of the residents of British Columbia.

- 2. To ensure that the facilities and services designated as necessary or essential are supplied, provided or maintained by the parties in full measure, the Board makes the following Orders:
 - a. The Employer shall utilize the services of its management and excluded personnel who are qualified to the best extent possible. Management and excluded personnel utilized to perform essential service work pursuant to this Order shall work a minimum of 60 hours total per week to the extent essential service work is available or unless otherwise agreed by the parties locally or otherwise ordered by the Board on application. Those management and excluded personnel qualified to perform work normally subject to call-out, shall be subject to call-out 24 hours a day, 7 days per week. The Employer shall, if requested by the Unions, record the daily number of hours and locations worked by each manager and excluded employee and forward a written record of the hours and locations worked to the Unions every 7 days.
 - b. Section 68 of the Code shall apply except where the Employer's management and excluded employees are performing essential work.
 - c. In addition to the requirements for service of strike notice under the Code, where any form of strike action may lead to the requirement that management or excluded personnel perform essential service duties, the striking union shall provide to the Employer 24 hours written notice of the particulars of that strike action including the location, date and time, duration and nature of the strike action and the numbers and classifications of employees within the striking union's bargaining unit whose performance of their duties may be affected.
 - d. The Employer shall schedule employees according to Schedules A and/or B subject to the right of either Union to give notice to take over the scheduling of its members in designated essential service positions.
 - i. Such notice shall be provided 48 hours in advance and shall specify the range of designated essential positions to be scheduled by that Union.
 - ii. The Union shall provide the schedule to the Employer at least 24 hours in advance of the employees' shifts.
 - iii. Where a shift is designated, that shift shall not be split between employees unless otherwise agreed to by the Parties.

- iv. Either Union may provide 48 hours' notice reverting responsibility to schedule to the Employer.
- e. Members of the IBEW and/or COPE scheduled to work at a work operation within a struck or locked out location shall be the only members of their bargaining unit who will work at that work operation within the struck or locked out location.
- f. The Employer shall direct those scheduled employees to perform the duties of their employment that it considers to be necessary or essential to comply with this Order.
- g. Each Union shall instruct its members to perform the work as directed above.
- h. Every employee shall perform the duties of his employment as directed above.
- i. The schedules, directions and instructions above shall be governed by the terms and conditions of the applicable collective agreement last in force between the Employer and the Unions, except as altered by this Order.
- j. Each employee scheduled to work regular hours shall also be subject to any standby or callout in accordance with the existing practice.
- 3. The Unions are ordered to provide unrestricted access and egress for those persons covered by this Order, and any other person or delivery required for the continued operation of the facilities and services designated by this Order.
- 4. The Unions may select one person to be present to observe the loading and unloading of any delivery vehicle randomly selected once per day at the loading/unloading point at any facility where deliveries are made. The observer shall not interfere with, or impede the loading or unloading process and shall not turn back any delivery. Observers may record these observations and if any activity contrary to this Order is observed, the Unions may apply to the Board for relief.
- 5. Employees will be available in the event of an emergency or disaster situation. In the event of a dispute between the Employer and the Unions as to whether an emergency or disaster situation exists, the employees will perform the work in question. If such dispute arises the Employer shall provide the Unions documentation and/or information in a reasonable period of time.

- 6. In the event of any disagreement between the parties regarding the interpretation or operation of any provision of this Order, any party may apply to the Registrar of the Board or his designate for final and binding expedited determination of the matters in dispute.
- 7. The Board retains the jurisdiction to monitor the operation of the facilities and services of the Employer during the dispute, and, on its own motion or application by any party, may make such change to this Order as may be necessary for the continued supply, provision or maintenance of the facilities, productions and services which are necessary or essential to prevent immediate or serious danger to the health, safety or welfare of the residents of British Columbia.
